Because this event is outside, we encourage a canopy in case of bad weather. **Access to electricity and/or water for your booth cannot be guaranteed. If you need access, please indicate so on this application.**

Setup time is on Sunday, 9/17, from 11:00 am – 12:45 pm. Booths should remain open until 5:00 pm. Your booth should be removed no later than 6:00 pm.
